

MICHA GDPR PRIVACY AND COOKIES POLICY

The Micha Design Company Limited ("we", "our", "Micha" or "Micha Solar") is committed to protecting the privacy of third parties (including its customers and all visitors to websites www.micha.co.uk and associated domains (the "Websites"). Please read the following Privacy and Cookies Policy which explains how we use and protect your information.

Key points to note

1. WHAT IS THE PURPOSE OF THIS POLICY?

We always try to protect your personal privacy and this Privacy and Cookies Policy is here to help you understand what we may do with any information you share with us. This Privacy and Cookies Policy only relates to the processing of your Personal Information by The Micha Design Company or on our behalf. The Micha Design Company only accepts responsibility for our Websites and does not extend to any websites that are linked from our Websites.

We will only use information from which you can be identified, such as your name, contact details and financial information ("**Personal Information**") which is provided to us, or otherwise obtained by us, in accordance with this Privacy Statement. We will ensure that your Personal Information is handled in accordance with the "Data Protection Legislation" (as defined at the end of this policy).

You can access our Websites homepages and browse our Websites without providing your Personal Information to us (save for some limited information we may collect depending on your browser settings), but if you do choose to give us your Personal Information by contacting us through the Websites (or otherwise engaging with us), you acknowledge that we may collect, use and transfer your Personal Information as set out in this Privacy and Cookies Policy. 2. WHO CONTROLS THE COLLECTION OF PERSONAL INFORMATION

In this Privacy and Cookies Policy, "**Micha**", "**we**", "**us**" and "**our**", refer to The Micha Design Company Limited, registered in England and Wales with registered office, The Micha Design Company Limited, Unit 1, Bridgegate Business Park, Aylesbury, Buckinghamshire, HP19 8XN Our company registration number is 2072488. For the purposes of the Data Protection Legislation, we are deemed to be the "data controller" in respect of any Personal Information that you provide to us in connection with the operation of our business or we otherwise obtain about you.

5 CUSTOMERS WHO PLACE AN ORDER WITH US

When you place an order with Micha, we ask for your name, e-mail address, delivery address, billing address, contact numbers and payment details. We keep a record of this information so that we can recognise you and fulfil any orders you place with Micha. We retain details of your orders and copies of any e-mail or written correspondence you send us in order to maintain high standards of customer service. Once you have placed your order, you will then be able to check on your order status.

6. HOW WE WILL USE YOUR DETAILS

We are committed to protecting your Personal Information and we will only use or disclose your Personal Information to (i) perform the contract we have with you, (ii) comply with our legal obligations, (iii) for our legitimate business interests (such as to analyse and improve our Websites, products and services), (iv) personalise your experience when you visit our Websites, (v) where you apply for a job with us, process your application and (vi) for any other purposes for which you have given your explicit consent.

In order to process your order we will send you a confirmation email or we may need to contact you by telephone or email to verify your details before we are able to process and dispatch your order or we may be unable to accept your order.

Where you have explicitly consented or where we otherwise have a right to do so, we may from time to time contact you by post, electronic mail or mobile phone messaging about new products, special offers or other information which we think you may find interesting using the contact information which you have provided.

From time to time, we may also use your information to contact you for market research purposes by email or mail. This will only happen where you have opted-in to receive such communications. We may also use the information to customise the Websites according to your interests.

7. ABOUT COOKIES AND HOW WE USE THEM

Cookies are small pieces of information in the form of text files that are sent to your browser from our web server and are stored on your computer. Overall, cookies help us provide you with a better website, by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than information about how you use the site and the data you choose to share with us (including data you automatically share with us by way of your browser settings).

8. SECURITY

We take security seriously and we take precautions to keep your Personal Information secure. We have put in place appropriate physical, electronic and managerial procedures to safeguard the information we collect and endeavour to only work with third parties who provide equivalent protections (for example, if you provide us with your payment information, the information is secure. However, due to the open communication nature of the Internet, we cannot guarantee that communications between you and us, or information stored on our servers, will be free from unauthorised access by third parties.

9. YOUR CONTROL OVER YOUR PERSONAL INFORMATION

In most instances we will provide the information within one month of receipt of your request, unless the request is particularly complex or we receive a large number of requests within that period, where we have the right to extend this period for two additional months. In this instance we will notify you of the delay and our justification.

You have the right to request that we amend your Personal Information (or part thereof) if you believe that any information we are holding on you is incorrect or incomplete. You also have the right to ask us to erase or stop processing any Personal Information we have about you where there is no longer a legal ground for us to hold it and, in some circumstances, you have the right to request that we transfer any information we hold about you to a specified third party. If you wish to exercise any of these rights, please write to or email us as soon as possible, at the above address or using the details below. We will promptly correct any information found to be incorrect.

10. HOW LONG WE RETAIN YOUR PERSONAL INFORMATION

Unless otherwise instructed by you, we will retain your Personal Information for only as long as we require for the purposes for which it was collected. Once the relevant purpose has been satisfied, we will securely delete or anonymise your Personal Information unless we are required to retain a copy of such information under applicable law.
